Re: Renewed Regulatory Framework for Electricity/Board Staff Discussion Papers, Consultants' Reports and Stakeholder Consultation Process/
Board File Nos.: EB-2010-0377, EB-2010-0378, EB-2010-0379, EB-2011-0043 and EB-2011-0004

We are counsel to the Consumers Council of Canada ("CCC").

We have received a copy of the Board's letter of November 8, 2011.

We have by separate e-mail correspondence, advised the Board that the CCC's consultant, Julie Girvan, will be participating in the Information Session commencing on December 8, 2011

It has been drawn to our attention that the CCC has applied for and been granted cost eligibility for all of the above-noted Board initiatives except EB-2011-0004. The CCC did not earlier submit a request for cost eligibility for that initiative. This letter is the CCC's request for cost eligibility in EB-2011-0004.

As the Board will be aware, the CCC has been an active participant in most, if not all, of the Board's policy-making initiatives for the regulation of the electricity sector, including those dealing with the Transmission System and Distribution System Codes.

The CCC requests that the Board find it to be eligible for costs on the following grounds.

The CCC is a non-profit, public interest organization, which represents the interests of the broad array of residential consumers of electricity in Ontario. The issues to be considered in the consultation process are ones which have a significant impact on residential consumers of electricity and, accordingly, the outcome of the proceeding will have an impact on the interests of those consumers. It is essential that the interests of residential consumers are represented and protected in the Board's consultation. Our client, therefore, has a substantial interest in the outcome of the consultation, and will participate fully in it.
