TO: All Electricity Distributors All Natural Gas Distributors All Other Interested Stakeholders

RE: Green Button Implementation – Industry-Led Working Group

On November 1, 2021, Ontario Energy Board (OEB) staff issued a <u>letter</u> that provided guidance to assist electricity and natural gas distributors' implementation of the Green Button standard in a timely, efficient and cost-effective manner.

In that letter, OEB staff stated that it intends to facilitate the establishment of a Green Button industry-led working group (GB IWG) and that the GB IWG would include members of the Green Button Task Force and other stakeholders interested in participating. OEB staff's guidance identified a number of issues that could benefit from further exploration in the GB IWG.

The purpose of this letter is to provide details of the establishment of the GB IWG and its first meeting. Appended to this letter is a listing of the invitees to the first meeting. Any organizations that have not already provided the name and e-mail address of their representative to the GB IWG meetings, are requested to provide that information to <u>Eamon.ORiordan@oeb.ca</u> by December 2, 2021. Any other stakeholder that is interested in participating should notify OEB staff as soon as possible through the same email.

The first meeting is planned for December 2, 2021, from 1:30 p.m. to 3:30 p.m. and will be held via Microsoft Teams. OEB staff will issue meeting invitations to GB IWG members and any meeting materials in advance of the first meeting.
