**RE: Notice of Review of Order Setting Uniform Transmission Rate  
OEB File No. RP-2001-0034/RP-2001-0035/RP-2001-0036/RP-1999-0044/  
EB-2005-0241/EB-2006-0501**

The Ontario Energy Board (the "Board") will review its Decision and Order dated December 8, 2005, which determined uniform pooled transmission rates and revenue allocations for the transmitters Hydro One Networks Inc., Great Lakes Power Limited, Canadian Niagara Power Inc. and Five Nations Energy Inc. The Decision and Order combined several proceedings under the file numbers RP-2001-0034, RP-2001-0035, RP-2001-0036, RP-1999-0044 and RP-2005-0241.

On September 28, 2007, the Board approved a new revenue requirement and new charge determinants for Hydro One Networks Inc. (Hydro One) transmission (EB-2006-0501), for 2007 and 2008. In order to reflect these findings in the Ontario Uniform Transmission Rates, it is necessary to review the transmission rates and revenue allocations for all transmitters in the Ontario Transmission Rate Pool.

The Board has combined the Hydro One transmission proceeding (EB-2006-0501) and the review of the December 8, 2005 decision and assigned Board File number EB-2007-0759 to this proceeding. The Procedural Order accompanying this Notice sets out the process for receiving submissions in the combined proceeding, with the aim of changing the uniform transmission rates on November 1, 2007. The Board invites submissions from affected transmitters and parties to the EB-2006-0501 proceeding.

If you do not respond to this notice in accordance with the enclosed procedural order, the Board may proceed in your absence and without further notice to you of this review.
