## Re: Revised Classifications of IESO Wholesale Market Service (WMS) Charge Type to the Uniform System of Accounts (USoA)

The Board has revised the classifications of the Independent Electricity System Operator (IESO) WMS charge types to the USoA accounts as shown in Appendix A. The revised classifications for recording WMS charges in accounts 4708, Charges WMS and 4712, WMS Charges – One-Time, will be effective from January 1, 2006. These changes will also impact the account balances related to the RSVA-WMS accounts 1580 and 1582.

The purpose of these revisions is to ensure adequate guidance is provided regarding how several changes to IESO charge types for wholesale market services are to be treated.

In addition, the classification categories of "recurring" and "non-recurring" WMS charge types have been discontinued by the Board. The WMS charge type classifications to account 4712 has been revised to include only charge types which are utility-specific and do not facilitate an automatic "pass-through" of costs in rates (e.g. administrative penalty – late payment). These may be subject to a prudency review of costs. All other WMS charge types are classified to account 4708.

The account description for account 4712, Charges – One-Time, is amended as follows to remove the reference of non-recurring charges:

A distributor that is a wholesale Market Participant shall use this account to record the wholesale market service charges from the Independent Electricity System Operator (based on the settlement invoice) that are not specified for recording in account 4708.

If applicable, embedded distributors shall also establish and use this account to record the amount charged by the host distributor (based on the settlement invoice) for wholesale market services.

Appendix A supersedes publicized information of IESO WMS type classifications in the 2000 Electricity Distribution Rate Handbook (EDRH - Chapter 11 dated March 29, 2001) and in the Board's letter of January 10, 2003 to the IESO re Table 1 (non-recurring wholesales service charges).
