The Ontario Energy Board (the "Board") is initiating a consultation with stakeholders on more innovative approaches to cost recovery for electricity infrastructure projects. The Board invites all interested parties to participate in this consultation.

Background

On April 3, 2009, the Chair of the Ontario Energy Board issued a Statement confirming the Board's commitment to creating conditions that will foster timely and appropriate investment in electricity distribution and transmission infrastructure while ensuring that the interests of ratepayers continue to be protected. On June 1, 2009, in a second Statement the Chair advised of the development of three initiatives, one of which is to consider more innovative approaches to cost recovery, primarily in relation to infrastructure investments relating to the accommodation of renewable generation and smart grid development. The cost recovery mechanisms developed through this initiative may also be available in relation to other types of projects in appropriate circumstances.

Staff Discussion Paper

For purposes of this consultation, the Board has released for comment a Board staff discussion paper. The discussion paper is now available on the Board's website at www.oeb.gov.on.ca.

The discussion paper sets out a range of mechanisms for the regulatory treatment of infrastructure investment that could be used to support the setting of rates. One or more of these mechanisms could be applied in the context of a cost of service review, a multi-year rate adjustment mechanism or a specific ("single issue") rate application. Other processes, such as the process for approving distributor and transmitter infrastructure investment plans, may also provide a forum in which some of the alternative mechanisms referred to in the discussion paper may be considered.

While the discussion paper identifies a number of issues in relation to which input from participants is specifically requested by the Board, participants should feel free to comment on all aspects of the discussion paper. Participants that wish to put forward alternative proposals or options for consideration are encouraged to include in their comments not only a detailed description of each proposal or option (including steps necessary for implementation, where applicable), but also the underlying rationale and principles that support the proposal or option. The Board will consider the comments received from interested parties in determining its policy on these issues.

Written comments must be filed with the Board by **July 7**, **2009** in accordance with the filing instructions set out below.

Cost Awards and Instructions on Filing Material with the Board

Cost awards will be available to eligible persons under section 30 of the *Ontario Energy Board Act, 1998* for their participation in this consultation. The costs awarded will be recovered as follows: 50% of the costs awarded will be recovered from all rate-regulated licensed electricity distributors, apportioned based on their respective distribution revenues; and the other 50% of the costs awarded will be recovered from all rate-regulated licensed electricity transmitters, apportioned based on their respective transmission revenues. The rates of licensed transmitter Cat Lake Power Utility Ltd. and the rates of licensed distributors Cornwall Street Lighting and Power Company Limited and Dubreuil Forest Products Ltd. are not currently fixed or approved by the

Board, and cost awards will not be recovered from these two distributors. **Attachment A contains important information regarding cost awards for this consultation, including in relation to eligibility requests and objections.** In order to facilitate a timely decision on cost eligibility, the deadlines for filing cost eligibility requests and objections will be strictly enforced.

Cost Award Eligibility

The Board will determine eligibility for costs in accordance with its *Practice Direction on Cost Awards*. Any person requesting cost eligibility must file with the Board a written submission to that effect by **June 16**, **2009** identifying the nature of the person's interest in this process and the grounds on which the person believes that it is eligible for an award of costs (including addressing the Board's cost eligibility criteria as set out in section 3 of the Board's *Practice Direction on Cost Awards*). An explanation of any other funding to which the person has access must also be provided, as should the name and credentials of any lawyer, analyst or consultant that the person intends to retain, if known. All requests for cost award eligibility will be posted on the Board's website.

Groups representing the same interests or class of persons are expected to make every effort to communicate and co-ordinate their participation in this process.

Rate-regulated licensed electricity distributors and rate-regulated licensed electricity transmitters will be provided with an opportunity to object to any of the requests for cost award eligibility. If an electricity distributor or transmitter has any objections to any of the requests for cost eligibility, such objections must be filed with the Board **June 23**, **2009**. All objections will be posted on the Board's website. The Board will then make a final determination on the cost eligibility of the requesting parties.

Cost Awards

When determining the amount of the cost awards, the Board will apply the principles set out in section 5 of its *Practice Direction on Cost Awards*. The maximum hourly rates set out in the Board's Cost Awards Tariff will also be applied.

The Board will use the process set out in section 12 of its *Practice Direction on Cost Awards* to implement the payment of the cost awards. Therefore, the Board will act as a clearing house for all payments of cost awards in this process.
