# **DECISION AND INTERIM RATE ORDER** ENBRIDGE GAS INC. - EB-2024-0111

## Decision on Enbridge's Major Rates Application (Phase 2)

On November 29, 2024, the Ontario Energy Board (OEB) issued its Decision and Interim Rate Order on a settlement proposal (the proposal) related to Phase 2 of Enbridge Gas Inc.'s (Enbridge) application to change its natural gas rates and other charges beginning January 1, 2024. Enbridge also asked for approval of an incentive rate-making mechanism (IRM) for the years 2025 to 2028. This is the second of three phases of Enbridge's application.<sup>1</sup>

The OEB has approved the Phase 2 proposal, agreed upon by Enbridge and intervenors, covering all but three<sup>2</sup> issues in the proceeding. These issues will be considered separately through an oral hearing. The OEB has accepted that the proposal is an appropriate basis upon which to establish just and reasonable rates, subject to the OEB's decision on the unsettled issues, and approved the draft rate order for updated 2024 and 2025 interim rates.

Approval results in a \$9.39M reduction to Enbridge's proposed 2024 revenue requirement.

#### Reductions include:

- An \$8.1M reduction specific to the revenue requirement related to the Dawn to Corunna project,
- A \$0.3M reduction to the allocation of unregulated storage costs,
- A \$0.1M increase to the working capital in rate base, and
- A \$1.0M base rate adjustment to reflect amounts paid by Enbridge Sustain to Enbridge Gas Inc. for services received but not been included in base rates.

The 2025 bill impacts for individual customers, resulting from the interim rate order, vary by rate zone and rate class. For a typical residential sales service customer, interim rates will result in an annual bill increase of:

- \$32.21 (or 2.5% of total bill) for a Rate 1 customer in the Enbridge Gas Distribution rate zone
- \$28.80 (or 2.1% of total bill) for a Rate 01 customer in the Union North rate zone
- \$29.97 (or 2.7% of total bill) for a Rate M1 customer in the Union South rate zone

#### **INTERVENORS**

Intervenors are individuals or groups who have permission to participate in a hearing before the OEB because they have a substantial interest in the proceeding. Twenty-one intervenors participated in the

settlement conference, and with few exceptions, all supported the issues that were settled. A full list of intervenors that participated in the settlement conference can be found in the Settlement Proposal filed November 4, 2024.
