Re: Tranche Assignments and Filing Due Dates for 2025 Incentive Rate-setting Mechanism (IRM) Electricity Distributor Applications

Providing clear and timely guidance to industry and facilitating the planning of application filings is a key part of the Ontario Energy Board's (OEB) commitment to making the regulatory process more transparent and efficient.

This letter sets out the expected filing date for each of the four 2025 IRM application tranches assigned to electricity distributors by the OEB. The application due dates have been set with regulatory efficiency in mind, namely to enable the OEB to process a large number of applications promptly and issue decisions in time for a January 1 or May 1 implementation date, as applicable.

The OEB expects to receive 41 IRM applications for 2025 rates, representing 53 different rate zones. The application tranches and due dates are for the 2025 rate year as follows:

Tranche 1 is for those distributors applying for a January 1, 2025 effective date for electricity rates. Applications for rates effective May 1, 2025 have been assigned to one of three subsequent filing dates based on their expected level of complexity, as reflected in distributors' responses to a survey conducted in May 2024.

Please see Schedule A, attached to this letter, which contains a complete list of the OEB's tranche assignments for the 2025 rate year. If a distributor assigned to tranches 3 or 4 contemplates a material increase in the complexity of its application relative to the information it provided in response to the May 2024 survey, the distributor must advise the OEB and is encouraged to file as part of tranche 2.

Applicants are expected to submit their applications to the OEB by 4:45 pm on the applicable filing due date.

The updated *Filing Requirements for Electricity Distribution Rate Applications: Chapter 3 – Incentive Rate-setting Applications*, and other instructions, are available on the <u>2025 Electricity Distribution Rate Applications webpage</u>. The IRM model for the 2025 rate year will be posted in July 2024.
