DECISION AND ORDER – EB-2023-0195 TORONTO HYDRO-ELECTRIC SYSTEM LIMITED

Decision on Toronto Hydro's Proposed Innovation Fund

On December 10, 2024, the Ontario Energy Board (OEB) issued a decision on Toronto Hydro-Electric System Limited's (Toronto Hydro) proposal to establish a customer-funded Innovation Fund. The Innovation Fund would support pilots of early stage, exploratory and developmental opportunities to prepare its distribution system for increased electrification and to integrate distributed energy resources.

The OEB denied the proposal for several reasons including:

- The OEB was not satisfied that the 100% customer-funded pilot projects would be cost-effective
 or in the best interest of customers.
- The OEB would not pre-approve cost recovery from customers for pilot projects without sufficient specifics about the proposal.
- There was not sufficient evidence on which to approve pilots funded only by Toronto Hydro's customers without knowing how those pilots could appropriately complement the existing Independent Electricity System Operator (IESO) Grid Innovation Fund program.
- The impact of the Innovation Fund on customer rates was uncertain given the lack of clarity on the mix of funding between capital and operations, maintenance and administration.
- Adjudicating the suggestions to improve the fund made by intervenors and OEB staff, some of
 which were not agreed to by Toronto Hydro, would inappropriately result in the OEB effectively
 re-designing the program and its management through an order.

The request to approve the Innovation Fund was part of Toronto Hydro's major rates application. The <u>settlement proposal</u> approved by the OEB earlier this year on all other aspects of that application included Toronto Hydro's 2025-2029 capital plan. That plan includes approximately \$444 million in funding for a grid modernization strategy, an advanced metering infrastructure 2.0 platform, an advanced distribution management system and a robust non-wires solutions program.

INTERVENORS

Intervenors are individuals or groups who have permission to participate in a hearing before the OEB because they have a substantial interest in the proceeding. Of the nine intervenors that made submissions on the Innovation Fund, four submitted that the OEB should reject the proposal, two intervenors plus OEB staff were critical but offered support on the condition that specific changes be made and three supported the proposal with certain improvements.

ABOUT THE OEB

The OEB is the independent regulator of Ontario's electricity and natural gas sectors. Commissioner panels hear and determine matters independently, with legislative protections and other instruments to ensure decisions are free from interference by the CEO, the Board of Directors and government. This also includes the Chief Commissioner when not assigned to the specific case.
