## EPCOR Natural Gas Limited Partnership (EPCOR)- South Bruce – January 1, 2025 Natural Gas Price Changes

EPCOR applied to the OEB to change the prices it will charge customers in South Bruce effective **January 1, 2025.** 

The OEB approved, on an interim basis, the following commodity rates effective **January 1, 2025** 

Gas Commodity Charge<sup>1</sup> (including quarterly adjustment) = **13.6170**¢/**m**³

Annual Commodity Rate Impact for an Average Customer (using 2,149 m³/year) = \$31.38

The OEB approved 2025 Distribution Charges.<sup>2</sup> The annual bill impact due to changes to 2025 Distribution charges for an Average Customer = **\$19.12** 

There are temporary rate riders being implemented in January 1, 2025.<sup>3</sup> The annual bill impact due to temporary rate riders = **\$121.66** 

Total Annual Impact for an Average Customer = \$172.17

The main reason for the commodity rate change is an increase in the forecast price EPCOR - South Bruce expects to pay for natural gas over the next 12-month period and the difference between actual gas commodity prices and the prices that were estimated last quarter.

**Note**: Natural gas rates are based on a forward-looking forecast for the next 12 months. Forecasts are never perfect, so the billed price is normally either higher or lower than the actual market price. The difference is tracked and passed on to consumers as a credit or a charge in subsequent quarterly rate adjustment applications.
